PLEASE INFORM THE ATHLETICS ONTARIO OFFICE OF ANY CHANGES THAT OCCUR ON THIS FORM THROUGHOUT THE SEASON.

Application for Affiliation must be made EACH cross Country Season and the fee paid in order for the club to exercise its right to vote at the Annual General Meeting of Athletics Ontario. Clubs are not members of Athletics Ontario until they submit a membership form and pay the appropriate membership fee. Membership expires each year on December 31 and is not renewed until the Club submits a new form and registration fee.

Athletes may not represent a club in any sanctioned competition unless that club is affiliated with athletics Ontario. It is the clubs' responsibility to ensure that athletes who enter or are entered in a 2010 competition are registered with Athletics Ontario.

NEW  ATHLETES MOVING TO A NEW CLUB FOR 2010 MUST SUBMIT A TRANSFER FORM SIGNED BY BOTH THEIR PREVIOUS AND NEW CLUB. REGISTERED ATHLETES WITH A CLUB MAY NOT TRANSFER TO ANOTHER CLUB DURING THE SEASON WITHOUT PERMISSION FROM ATHLETICS ONTARIO'S BOARD OF DIRECTORS.

Note: For voting privileges at the Athletics Ontario A..G.M. an affiliated club must have a minimum of 5 registered Athletics Ontario members for the Cross Country season.

All Clubs should be in possession of the Athletics Ontario Policies and Procedures Manual. A manual may be obtained by contacting the Athletics Ontario office.
